Summary

On November 28, 2016, the U.S. Department of Housing and Urban Development (HUD) published a Federal Register Notice (FRN), outlining funding from Public Law 114-223. The FRN made an initial allocation of \$437,800,000 in Community Development Block Grant-Disaster Recovery (CDBG-DR) funds, to support the State of Louisiana's recovery efforts from the March and August severe storms and flooding events. On January 18, 2017, HUD published a second FRN, allocating an additional \$1,219,172,000 of funding, under Public Law 114-245.

Prior to making funding available, HUD requires the state to create an Action Plan, that documents the proposed use of funds, and to publish it for public comment. The Action Plan must address the requirements and priorities identified in the FRN. After the initial funds were allocated, The State of Louisiana Office of Community Development-Disaster Recovery Unit (OCD-DRU) posted an Action Plan for public comment on December 8, 2016, and received public comments until January 3, 2017. Due to changes in the second FRN, HUD required OCD-DRU to draft an Action Plan Amendment, to address new requirements and priorities. OCD-DRU posted an Action Plan Amendment 1 for public comment on January 24, 2017. The comment period will officially end on February 15, 2017. Allocation of Funds

In the Action Plan Amendment 1 now out for public comment, the state is proposing to allocate \$1,656,972,000 to the following Programs:

The State of Louisiana Proposed Recovery Programs

The below information provides a summary of the programs proposed in the Action Plan. Full program descriptions are available in the <u>Action Plan Amendment 1</u>.

Restore Louisiana Homeowner Rehabilitation, Reconstruction and Reimbursement Program

This program will cover eligible costs for the repair or replacement of damaged housing; replacement of disaster-impacted residential appliances; and environmental health hazard mitigation costs related to the repair of disaster-impacted property. The program provides the below solutions for homeowners:

- **Track 1: Program Managed:** The state manages and completes the construction process for the rehabilitation or reconstruction of damaged homes on behalf homeowners. The state will contract with a pool of contractors and assign them to repair, or reconstruct damaged properties. Homeowners will not select their own contractor, and will not contract with the construction contractor.
- **Track 2: Homeowner Contracted Program:** Homeowners choose to manage their own rehabilitation or reconstruction process with the state providing construction advisory services for all homeowners.
- **Track 3: Reimbursement:** Homeowners who have completed partial or full repairs on their home before applying to the program may be eligible for reimbursement of eligible expenses incurred prior to application to the program and within one year of the storm event.
- *Track 4: Voluntary Buyouts or Acquisitions:* Based on further analysis of unmet needs, the state may execute voluntary buyouts or acquisitions in limited situations.

Due to limits in the funding available, the state will first prioritize homeowners meeting the following criteria:

- The impacted home experienced Major/Severe Damages by either a FEMA-designation or have damage which meets the major/severe damage standard that FEMA has defined;
- The applicant household meets federal low-to-moderate income (LMI) requirements;
- The applicant or co-applicant is elderly (age 62 on the date of the disaster event) OR is a person with disabilities or has a person with disabilities in the household;
- The home is located outside the Special Flood Hazard Area (floodplain); and
- The home did not have flood insurance at the time of the flood.

Once this population's needs have been addressed, the state will prioritize additional homeowners in phases. For more information on prioritization, see the Action Plan Amendment 1 on OCD-DRU's website.

Restore Louisiana Rental Housing Programs

The state is proposing a portfolio of three rental programs to address the immediate and long-term housing needs of LMI families in the flood impacted areas. Due to the shortage of affordable housing stock, it is imperative to provide solutions to address immediate housing needs and provide alternative housing solutions for rental properties in need of long-term recovery.

Rental Incentive Program: To prevent the loss of affordable rental housing, the state will work with landlords to subsidize the difference between the Fair Market Rents and the rent a tenant can afford to pay.

Infill and Rehabilitation Rental Program: This program seeks to rehabilitate or create new affordable housing units through the creation of a partially forgivable loan program.

Multifamily Rental Gap Program: This program will provide loans to meet the gap of funding needed to repair large rental properties (20 units or more).

Restore Louisiana Economic Revitalization Programs:

The state understands that residential communities cannot fully recover and thrive without the businesses returning to the community. Therefore, the state has proposed the below economic revitalization programs to support the overall community recovery needs.

Small Business Grant and Loan Program: This program will work with local community development organizations to develop a lending program that covers non-construction related expenses for disaster-impacted small businesses.

Small Business Technical Assistance Program: The program will provide business technical assistance services as part of loan underwriting and loan servicing processes.

Louisiana Farm Recovery Grant Program: This program will assist impacted, individual farm enterprises.

Infrastructure Programs:

The flooding events of 2016 exposed vulnerabilities in the state's infrastructure system. Investments in infrastructure repair and rebuilding will undergird the state's investment in housing repairs throughout impacted communities.

FEMA Public Assistance Nonfederal Share Match Program: The state will use funds to offset the burden of the non-federal share match requirements faced by state and local entities resulting from FEMA PA projects throughout the state.
