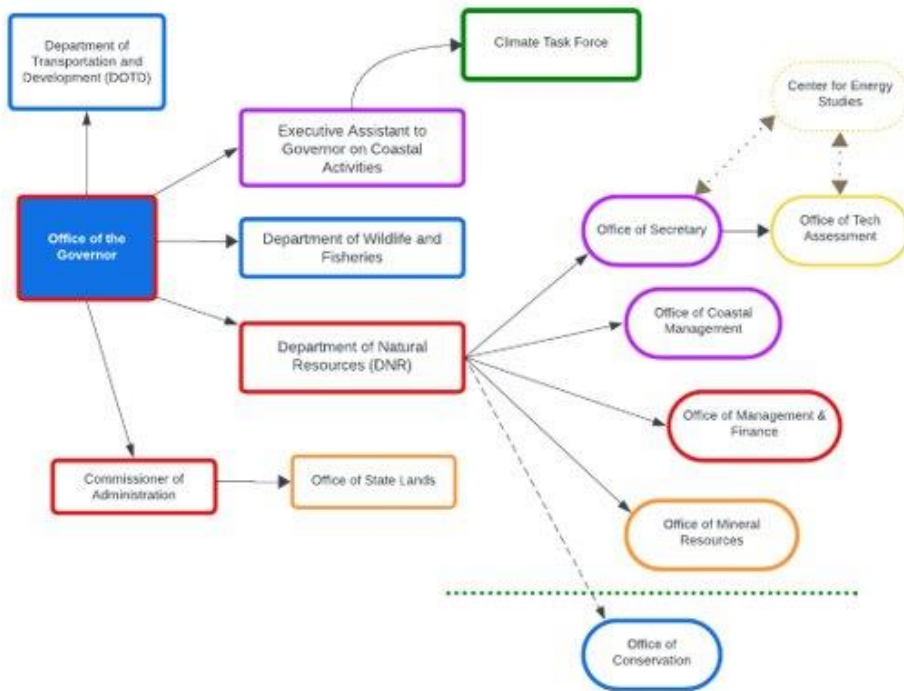

Efficiency and Coordination

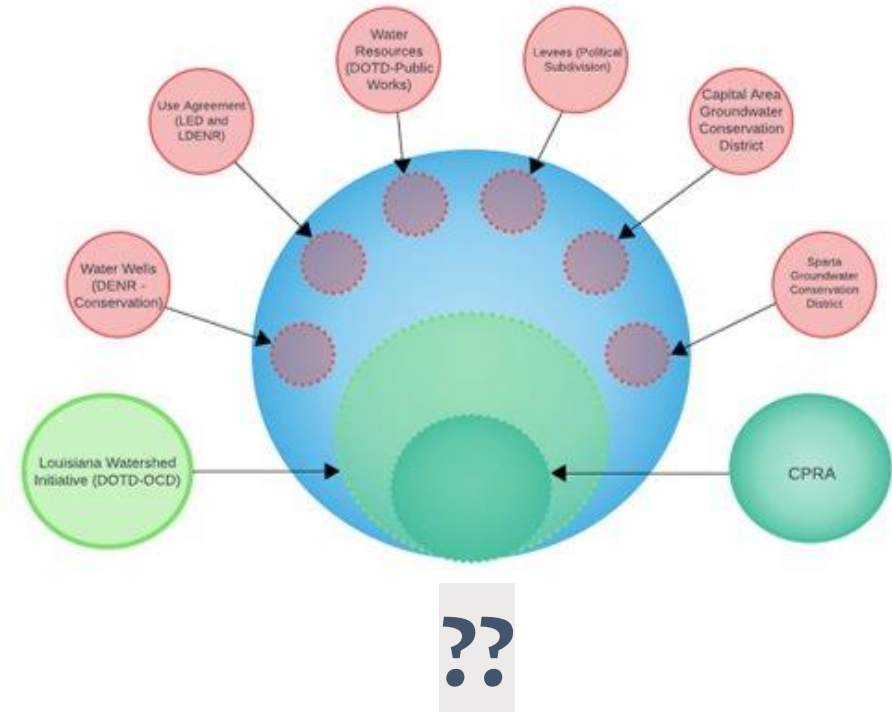
Improve efficiency and coordination through streamlining functions, optimizing staff, and establishing coordination across agencies.

- **Collaboration and Data Sharing:** Foster collaboration and information sharing across agencies to improve agency decision making.
- **Emergency Response & Risk Management:** Establish a dedicated emergency response function of DENR to bring a focus on preparedness, risk management, and financial security related to natural resources.
- **Infrastructure Consideration:** Manage natural resources and associated infrastructure in a way that complements the state's overall infrastructure needs.



Purpose Governance

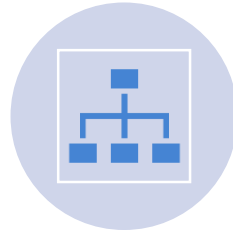
- **Strategic Planning:** Revise and develop strategic plans for natural resources management.
- **Organization and Alignment:** Align and streamline DENR functions.
- **Scope, Standardization, and Guidelines:** Create uniform guidance to ensure consistency and clarity in agency decision making.
- **Clarifying Relationships:** Clarify and optimize relationships with various government and quasi-governmental entities.



Framing Issues



DENR was founded in 1976 to promote the sustainable and responsible use of the natural resources of Louisiana so they are available for the enjoyment and benefit for the present and into the future.



Since 1976, DENR has not undergone a major reorganization or modernization, while other agencies have done so multiple times. This has resulted in bureaucratic hurdles and fractured management of natural resources across state government, which has hindered effective operations.



Lack of engagement or expertise in finance and banking sector with respect to natural resources management. An impending fiscal shortfall in Fiscal Year 2025 also necessitates a reorganization to improve efficiency and create sustainability within natural resources management.



DRIVE is meant to provide a balanced approach to compliance, management, enforcement, and implementation as it relates to the state's natural resources. The proposed reorganization and integration of DENR will address the improper alignment of goals and resources and create a holistic analysis and approach to natural resources management.



Background and Project History

- On February 2, 2024, Governor Landry issued Executive Order JML 24-13, directing DENR to investigate consolidation and reorganization of the State's natural resources management regime.
- DENR consulted with multiple stakeholders, both internal to government and non-governmental, and considered public comments.
- On February 23, 2024, DENR issued a request for executive action to Governor Landry, requesting Governor Landry to identify needed legislative changes.
- On March 11, 2023, Governor Landry addressed a letter to DENR creating the Natural Resources Steering Commission and directing several legislative changes to be made.



Legislative Changes 2024 Regular Session

- **House Bill 806**

- Authored by Rep. Brett Geymann.
- Provides for Membership of the CPRA Board.
- Removes DOTD secretary, LED secretary, Commissioner of Administration, Commissioner of Agriculture, Commissioner of Insurance, & GOHSEP from CPRA board.
- Adds 3 at large appointments for the Governor.



Legislative Changes

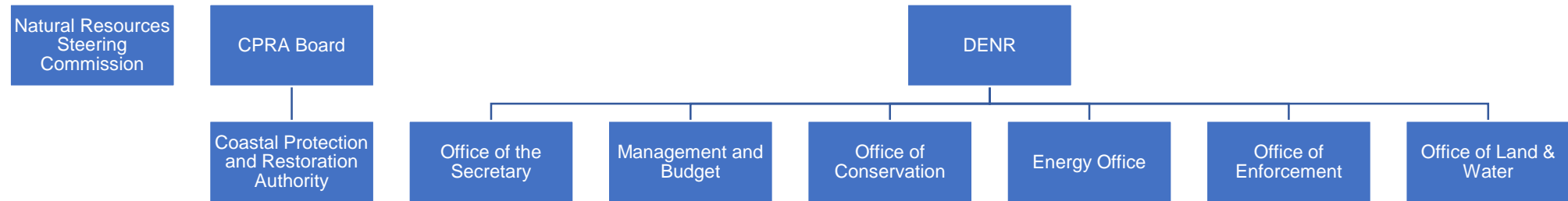
2024 Regular Session

- **House Bill 810**

- Authored by Rep. Brett Geymann and Jacob Landry.
- Provides for the organization, duties, and responsibilities of the Dept. Of Energy and Natural Resources.
- Creates offices of Energy, Enforcement, and Land & Water.
- Creates Natural Resources Trust Authority.
- Transfers LOSCO to DENR.
- Removes "firewall" between Commissioner of Conservation and DENR Secretary.
- Grants authority over certain functions involving state lands and waterbottoms to DENR.



Proposed HB 810 Organizational Structure

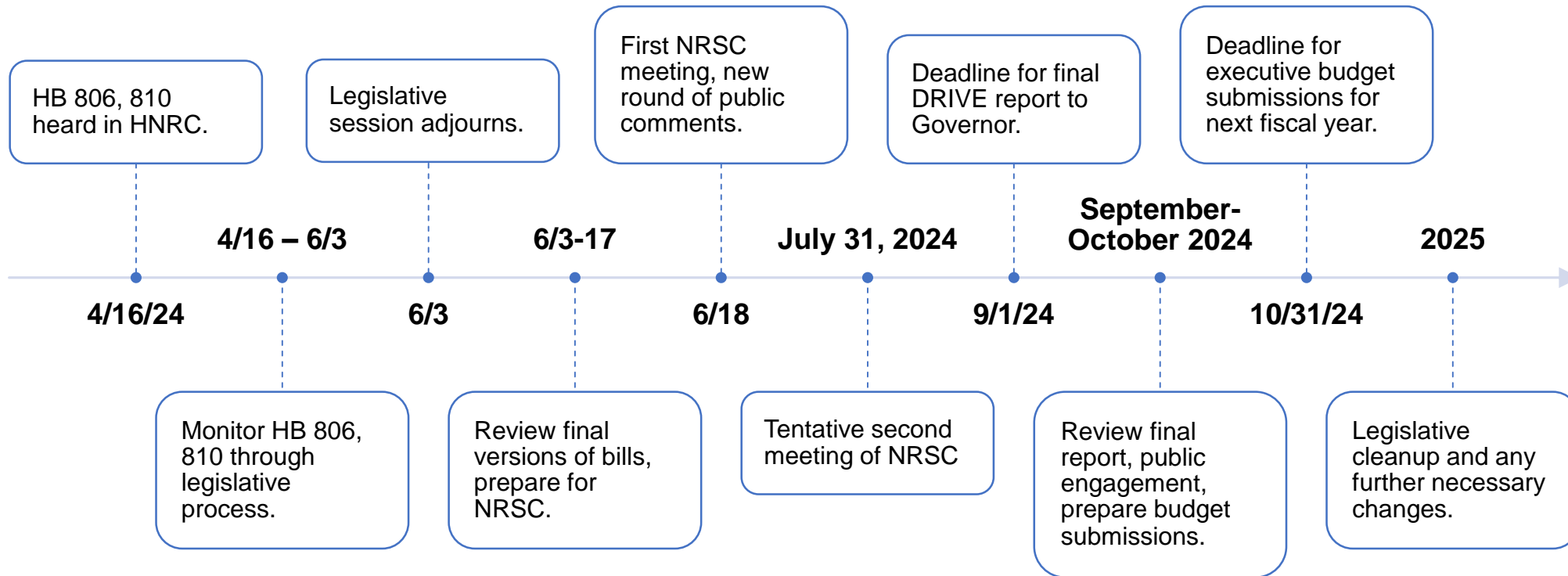


Working Groups

- **Office of Secretary** - Support function for DENR focused on intra and intergovernmental affairs, including state legislature and legal.
- **Management and Budget** - The backbone of DENR with Human Resources, Fiscal, Natural Resources Trust Authority and other operational services.
- **Energy** - Direct relationship with the federal Department of Energy focused on research, policy, power, strategy, public engagement, innovative partnerships, and other forward looking activities.
- **Conservation** - Office focused on permitting, regulatory, and compliance of operations.
- **Enforcement** - Focused on enforcement of out of compliance operators.
- **Land & Water** - Programmatic and management function, land, water, minerals, storage, power.
- **Implementation** – construction arm of and for natural resources including infrastructure, remediation and restoration, and CPRA.
