PROCLAMATION NUMBER 138 JBE 2020

***EARLY VOTING LOCATIONS RELOCATED DUE TO
STATEWIDE STATE OF EMERGENCY CAUSED BY
HURRICANE DELTA***

WHEREAS, the Governor declared a Statewide Emergency via Proclamation Number 133 JBE 2020 on October 6, 2020, in response to the imminent threat posed by Hurricane Delta;

WHEREAS, the Secretary of State has certified to the Governor, on October 13, 2020, that a state of emergency exists that would affect the electoral process, pursuant to La. R.S. 18:401.1;

WHEREAS, early voting for the November 3, 2020 election is scheduled to be conducted on Friday, October 16, 2020 through Tuesday, October 27, 2020, excluding Sunday, October 18, 2020 and Sunday, October 25, 2020 from 8:00 a.m. until 7:00 p.m. at the Office of the Registrar of Voters, 148 Smith Circle, Cameron, Louisiana;

WHEREAS, early voting for the November 3, 2020 election is scheduled to be conducted on Tuesday, October 20, 2020 through Thursday, October 22, 2020 at the Grand Lake Library, 10200 Gulf Highway, Grand Lake, Louisiana;

WHEREAS, early voting for the November 3, 2020 election is scheduled to be conducted on Monday, October 26, 2020 at the Hackberry Community Center, 980 Main Street, Hackberry, Louisiana; and

WHEREAS, due to the damage caused by Hurricane Delta, the Office of the Registrar of Voters located at 148 Smith Circle, Cameron, Louisiana cannot be used as a location for early voting for the November 3, 2020 election.

NOW THEREFORE, I, JOHN BEL EDWARDS, Governor of the State of Louisiana, by virtue of the authority vested by the Constitution and the laws of the State of Louisiana, do hereby order and direct as follows:

SECTION 1: early voting for the November 3, 2020 election scheduled for Friday, October 16, 2020 through Tuesday, October 27, 2020, excluding Sunday, October 18, 2020 and Sunday, October 25, 2020, is hereby relocated from the Office of the Registrar of Voters, 148 Smith Circle, Cameron, Louisiana to the Grand Lake Library, 10200 Gulf Highway, Grand Lake, Louisiana.


SECTION 2: early voting for the November 3, 2020 election scheduled for Monday, October 26, 2020 at the Hackberry Community Center, 980 Main Street, Hackberry, Louisiana shall be extended to take place on both Monday, October 26, 2020 and Tuesday, October 27, 2020 at the Hackberry Community Center, 980 Main Street, Hackberry, Louisiana.

SECTION 3: These elections shall be held and conducted under the applicable provisions of the Louisiana Election Code, La. R.S. 18:1, *et seq.*

SECTION 4: The Secretary of State, Commissioner of Elections, Parish Boards of Election Supervisors, Clerks of Court, Registrars of Voters, and all other persons charged with any power, function, right, duty or responsibility in conducting elections in the State of Louisiana are hereby authorized, requested, directed and empowered to exercise every lawful function and to do every act necessary to conduct these elections, to cause the returns to be made, to canvass and promulgate the results, and to perform all related and incidental functions.
