PROCLAMATION NUMBER 12 JBE 2023

**RECALL ELECTION – PARISH OF SABINE –
JEFFREY KENT DAVIDSON, POLICE JUROR, DISTRICT 5**

- WHEREAS,** pursuant to La. R.S. 18:1300.1, *et seq.*, any public officer, except judges of the courts of record, may be recalled, provided that statutory mandates are met;
- WHEREAS,** a recall petition has been filed with the Registrar of Voters for the Parish of Sabine seeking the recall of Jeffrey Kent Davidson, Police Juror, District 5, Parish of Sabine;
- WHEREAS,** the Registrar of Voters for the Parish of Sabine has reviewed, certified, and forwarded to the Governor the recall petition with certification that the number of names appearing on the petition is six hundred and twenty-five (625); the number of qualified electors in the voting area whose signatures appear on the petition is six hundred and fifteen (615); and the total number of electors in the voting area as of the date of the filing of the recall petition with the Secretary of State was one thousand six hundred and thirty (1,630);
- WHEREAS,** thirty-three and one-third percent (33⅓ %) of 1,630 voters would require at least five hundred and forty-four (544) valid signatures on the petition to satisfy the statutory requirements for a recall election for an area with one thousand or more but fewer than twenty-five thousand (1,000-24,999) qualified electors residing in the voting area, as provided in La. R.S. 18:1300.2(B)(3)(b);
- WHEREAS,** the recall petition was signed by at least thirty-three and one-third (33⅓ %) percent of the electors of the voting area, as required by La. R.S. 18:1300.2(B)(3)(b); and
- WHEREAS,** the provisions of La. R.S. 18:1300.7 direct that when the certification of the Registrar of Voters demonstrates the required number of qualified electors of the voting area signed the petition, the Governor shall issue a proclamation ordering an election to be held on the next available date specified in La. R.S. 18:402(F) for the purpose of voting on the question of the recall of said officer.

NOW THEREFORE, I, JOHN BEL EDWARDS, Governor of the State of Louisiana, by virtue of the authority vested by the Constitution and the laws of the State of Louisiana, do hereby order and direct as follows:

- SECTION 1:** A special election shall be held within the Parish of Sabine, on Saturday, April 29, 2023, for the purpose of voting on the question of whether Jeffrey Kent Davidson, Police Juror, District 5, Parish of Sabine, shall be recalled.
- SECTION 2:** The officers charged by law with duties in connection with the recall election described in Section 1 shall cause the special election to be held on Saturday, April 29, 2023, and the returns thereof to be made in the manner and form prescribed by law.
